- **Regular reconstruction and rehabilitation of roads-** Under the scope of **25 02 02 01**, the most works were accomplished that were foreseen in the annual plan of 2015, whilst in 2016 transitive sites have been rehabilitated. In addition, works to lay asphalt-concrete pavement and rehabilitate bridges and other artificial building have been continued.
- **coastal protection works-** Under the scope of **25 02 02 07**, shore-protection activities have been implemented during 2014-2015 and completed for 3 sites. In 2015, shore-protection activities were implemented and completed for 15 sites, whilst works at 3 transitive sites have been in progress.
- **Tianeti -Zaridzeebi- Zhinvali road construction, reconstruction and rehabilitation work** Under the scope of **25 02 02 08,** soil excavation and culvert arrangement works have been implemented. Construction works have been delayed during the reporting period.
- Secondary and local Road project II (WB) 25 02 02 09 Within the framework of the progress rehabilitation works were implemented in the remaining 2 items, in particular, Tbilisi-Tianeti's road km39-

km51 section and Chiatura-Perevisa-sveri-Sveri-Gezruli's Road km 8 - km 22, which was intended to finish at the first half of 2016.

- Secondary and local Road project III (WB) -25 02 02 10 In 2015, 3 sites were completely rehabilitated, while in 2016 the transitive sites have been under the rehabilitation works. The tender was announced for 2 sites, project documentation was prepared for the rest 8 sites.
- Kakheti Regional Roads Development Project (WB) Under the scope of 25 02 02 11 01, the dining-Sioni road rehabilitation work has been completed. Also, in Kakheti Region, the first and second phases of road safety measures for 9 sections have been accomplished.
- Kutaisi (Nikea str.) Geguti node section reconstruction-modernization -25 02 02 12 Tender procedures completed and the winner company was awarded.
- Stepantsminda- Sameba Church Road 1-6 st-km section construction- reconstruction 25 02 02 13 Discussion of resettlement action plan.
- East-West transit autobahn III (Sveneti Ruisi)(WB) 25 02 03 01 The works foreseen under the project completed.
- Additional Financing for the Third East-West Highway Improvement Project (Ruisi-Agara) (WB) 25 02 03 02 – Completed the roadbed, culverts and underpasses works. Overpasses performed piles unifying slab works. Completed works for overpasses and bridge construction, arrangement of road pavement and concrete pavement. Executed works for placing dividing line of "New Jersey" type concrete barriers and arranging confines with metal beams and curved bars for the road sections and arrangement of asphalt pavement for transport lanes foreseen under the road project.
- Fourth East-West Highway Improvement Project (WB) 25 02 03 03
  - The works for topsoil removal, storage and cement concrete pavement foundation, embankment, culverts, underpasses and the construction of concrete pavement and Communication (water pipes) relocation have been in progress.
- Road Corridor Investment Program (Kobuleti Bypass Road) (ADB) 25 02 03 05 01 Lot I the traffic movement on a newly built 12.4 km-long section is open. Defect period is completed. Also, gabion walls arrangement was completed for the 30-33 km section.
  - Lot II Works for arrangement of piles for foundation, beams, columns and crossbars, abutments have been implemented. Under the roadbed, a reinforced culverts underpasses works have been undertaken. Due to N1 tunnel excavation and temporary cover arrangement, concrete spraying works have been done. And, in terms of N2 tunnel, open method of excavation has been used as it was envisaged in the project. Also, relocation works of Communications (gas pipeline) have been implemented.

### Second Regional Development Project (Imereti) (WB) - 25 02 03 06:

Construction works on Kutaisi bypass road (km0+000-km17+300) have been completed. The traffic movement has already been open.

- Soil excavation works have been undertaken in Kutaisi Bypass-Samtredia Section (km0+000-km24+045) During the reporting period, construction and rehabilitation works of bridges and overpasses completed, concrete pavement was arranged on the main road and shore protection measures were accomplished. On a newly developed 14.8 km section, traffic movement has been launched, and in the rest 9.2 km part of the road is planned to open in 2016.
- On Zestaponi Kutaisi Bypass (km0-km15+175) the following works have been executed: land excavation, arrangement of culverts and underpasses. The construction works for arrangement of piles for foundation, beams, columns and crossbars have been implemented on the bridges. Under the roadbed, a reinforced culverts underpasses works have been undertaken. It also included manufacturing and installation of prestressed concrete beams. On the main road, new concrete pavement has been arranged and communications have been relocated (High and medium pressure oil pipes and high and medium voltage el. cables). The works for placing dividing line of "New Jersey" type concrete barriers and arranging confines with metal beams and curved bars for the road sections.
- Modernization and Construction of the Samtredia Grigoleti road km 0 50-km section(EIB, EU) 25 02 03 07
- Within the program Samtredia Grigoleti (Lot I) km0+000-km11+500, vegetation layer has been removed and stored, also the works for arranging roadbeds, piles for foundation, beams, columns and crossbars for bridges and overpasses have been implemented. Moreover, vertical drainage and geogrids under the roadbed have been arranged. On the section of Samtredia – Grigoleti (Lot II) km11+500-km30+000 the winner company has been announced and contract has been signed. On the section of Samtredia – Grigoleti (Lot IV) km42+000-km51+570 preparation and mobilization works have been completed. Topsoil has been removed and stored. Also, on the sections envisaged within the project, under the roadbed stone columns have been arranged and communications (el. cables) have been relocated.

#### • Sustainable Urban Transport Investment Program (ADB) - 25 03 04

During the reporting period, the following activities were accomplished under the scope of subproject: construction and modernization of Tbilisi-Rustavi section (I and III Sections) of Tbilisi-Red bridge(boarder of Azerbaijan) road, land acquision and distributing appropriate compensition to the population; moreover, under the scope of Tbilisi-Rustavi Highway Project (section 2, km 5.2 – 6.9) investigation has been carried out to estimate vibration on the nearby buildings, assess impact of noise and analyze structural integrity.

Designing, procurement, construction permit and supervision have been arranged; under this project, on Tbilisi-Rustavi section (km4+000-km10+800) of Tbilisi-Red bridge(boarder of Azerbaijan) road archaeological study has been conducted. Designing works, procurement, construction, management and supervision have been launched for Subway Station "University" that is going to be continuation of second line of Tbilisi Metro. Shore protection (I phase) and constructing buildings (II phase) have been carried out in Anaklia which included projecting and supervising the works. The reporting period also covered preparation of Batumi shore protection project, procurements, construction works and supervision.

• Regional Development Project (Kakheti) I part (WB) - 25 03 05

Duing the reporting period, the following activities were accomplished under the scope of subproject:  $\geq$ arranging touristic infrastructure at cultural heritage (Old Shuamta, New Shuamta, Ikalto and Yovladtsminda) and conservation works of Ikalto Church (II phase); revision of design documentation prepared for arrangement touristic infrastructure at cultural heritage, such as Old Shuamta, New Shuamta and Ikalto; slight rehabilitation and arrangement touristic infrastructure at cultural heritage sites of Ninotsminda and David Gareja (II phase); revision of design documentation prepared for arrangement touristic infrastructure at Ninotsminda; revision of design documentation prepared for arrangement touristic infrastructure at David Gareja; arranging touristic infrastructure at cultural heritage at Ujarma, Gurjaani and Khirsa; eradicating defects during rehabilitation works at resort Akhtala, located in Gurjaani; Restoration of Batoni Castle (Palace) in city Telavi (II Phase); Rehabilitation of Batoni Castle (museum and territory) (II Phase), designing construction of new museum at Batoni Castle, development of plan of tourism management at the architectural complex of Batoni Castle and organizing exposition; Rehabilitation of "Telavi Khevi" located at Ketevan Tsamebuli Street in Telavi; cleaning and restoring dumpsite for construction waste situated in the entrance of city, near village Vardisubani; Rehabilitation of access road to Wine Storage of the village Shalauri, Telavi Municipality; Carrying out safety measures on Tusheti road; rehabilitation of buildings and arranging touristic zone in Dartlo and other villages of Tusheti (II phase); procuring respective service from the National Agency for Cultural Heritage Preservation for providing design for buildings which were in needs of rehabilitation; Designing wastewater, pipeline and treatment plant in village Omalo; procuring engineering supervision service for ongoing projects in Kakheti region, which are implemented with financial support of the World Bank; consulting service for development of employee's skills in the tourism; consultancy service of monitoring and assessing tourism in Kakheti region.

#### • Second Regional Development Project (Imereti) (WB) - 25 03 06

During the reporting period, the following activities were accomplished under the scope of subproject:  $\geq$ Preparation of design documentation for arranging touristic infrastructure near the Motsameta Monastery Complex; Preparation of design documentation for arranging touristic infrastructure near the Katskhi Monastery Complex and for reconstruction of preasts' dwellings and buldings for preachers; preparation managing plan for The world Heritage Site - Gelati Monastery; arranging amenities for cultural heritages nearby the Monastery Gelati and Ubisa; Rehabilitation of pavement of ring and its drainage system at Tskaltubo (II Phase); rehabilitation of "Cold" Lake and roads, tracks and drainage system at the Central Park of Tskaltubo(II Phase); construction of buildings for touristic purposes at the Central Park of Tskaltubo, as well as nearby of "Cold" Lake; Construction of administration office for the resort; Greening and installation watering system at the Central Park of Tskaltubo and the "Cold" Lake; Rehabilitation of outdoor lighting at the ring road of Tskaltubo, Central Park and surroundings of "Cold" Lake; Rehabilitation works of Municipality and Theater of Tskaltubo; Inner rehabilitation works for the building of "City Assembly" and Railway; Rehabilitation of footbridges; Rehabilitation of archaeological museum of City Vani (completion of construction a new building of the museum) (II phase); under the scope of Regional Development Project II providing consultancy service for the planned projects in Imereti Region; Rehabilitation-conservation works of Gelati Monastery; Providing safety roofing of Vani archaeological sites and rehabilitating areas of the museum and the resort; praparing detailed design documentation for reservation for Vani Archaeological Museum; providing consultancy service for development of skills and abilities of employees in the service management of Tourism; consultancy service of monitoring and assessing tourism in Imereti region; Preparing variation package of design documentation for Katskhi and Ubisa Monastery; praparation managing plan of tourists for specific cultural heritages.

### • Kutaisi Solid Waste Managment Project (KfW, EU) - 25 03 09

- Within the framework of the project, based on the tenders announced according to KfW guidelines and regulations, two consulting companies have been awarded and, consequently, the parties signed an agreement:
  - ✓ Project Implementation Consultant ERM (The contract was signed on 9 June 2015), which is financed from the Loan.
  - ✓ -Accompanying Measures Consultant PEM Consult (The contract was signed on 21 April 2015), which is financed from the Grant.
- On the selected area for the new sanitary landfill (the former soviet military base) special surface clearance works were executed by the British Humanitarian Demining organization "Halo Trust" which was contracted by the Company.
- Project Implementation Consulting Company has studied potential territories for transfer stations in Samtredia, Sachkhere, Tkibuli, Ambrolauri, Oni and Tsageri Municipalities. The process of analyzing results of Feasibility Study and making updates has been carried out. Due to preparation of landfill design, the selected consultant has conducted topographical survey of the territory and developed documentation (as the basis of landfill design).

### • Constraction and maintain of Ski and mountin Infrastructure in the Upper Svaneti -25 03 11

Under the subproject:

- ✓ Contractor organization, which carried out the works on soil, has accomplished 95 % of contractual obligations;
- ✓ Under the RMS contract, contractor organization has carried out the works associated with ropeway T2. In addition, during this period construction of administrative office, control cabins, garages and other additional infrastructure was completed.
- ✓ During the reporting period, T3 and T4 ropeways were installed.
- ✓ The agreement has been signed over design service for TH and T7 ropeways and nearby infrastructure and associated works were carried out.

## • Rehabilitation and Reconstruction of Chiatura's Gondola Lifts (Government of France) - 25 03 12

- During 2015, under the scope of reconstruction-rehabilitation Project of Kutaisi Ropeways, French Company "Pomagalski" carried out investigation of ropeway track directions. Resettlement Action Plan was developed which has created basis for land acquisition. Design Documentation was prepared for construction works.
- Third Regional Development Project (Samtskhe-Javakheti and Mtskheta-Mtianeti) (WB) 25 03 19

During the reporting period the following activities have been implemented under the subproject: In  $\geq$ Stepantsminda, design documentation and cost estimate were prepared for rehabilitation of Aleksandre Kazbegi historic museum; design documentation and cost estimate were prepared for the access road to Bagineti Archaeological Complex in Mtsketa Municipality; rehabilitating access road to Gergeti Temple and path to the Trinity; Preparation of Design documentation and cost estimate for parking space of Dariali Monastery and for rehabilitation works on path accessing the monk houses; Preparation of Design documentation and cost estimate for access road to Sapara Monastery, Akhaltsikhe Municipality; the contract was signed to implement rehabilitation works on the access road to Sapara Monastery; the contract was signed to prepare Design documentation and cost estimate for arranging touristic infrastructure nearby the Monastery Complex; Preparation of Design documentation and cost estimate for rehabilitation access road to Gogasheni village and safety measures arrangement in Akhalkalaki Municipality; the contract was signed to prepare Design documentation and cost estimate for Bakuriani central paths arrangement works; the contract was signed to prepare Design documentation and cost estimate for developing touristic infrastructure at Bakuriani recreation park; the service to prepare Design documentation and cost estimate for Ananuri Castle Complex; Consulting Service for economic and fiscal analysis for the third project of regional development; Procurement of the UNESCO Consultancy Service for the National Agency of Cultural Heritage; Reimbursement of the World Bank Loan Service.

#### • Kobuleti Wasterwater Project (EBRD, ORET) -25 04 01

During the Reporting Period under the scope of subproject, wastewater treatment plant was under construction in Kobuleti. Due to delays in project progress, contract with the contractor has been terminated. On this stage, new tender has been announced for completion of works.

### • GeorgiaWater Infrastructure Modernisation project (EIB) -25 04 02

During the Reporting Period under the scope of subproject, water supply system rehabilitation project has been completed in Chokhatauri (III phase) and Zestaponi. Water supply system rehabilitation was carried out in Terjola.

### • Water Infrastructure Modernisation Project II (EIB, EU) -25 04 03

- During the Reporting Period under the scope of subproject, watersupply system and pipeline rehabilitation project has been carried out in the following towns: Akhmeta, Lagodekhi, Sagarejo, Telavi-Kurdgelauri, Gurjaani, Oni, Tkibuli, Zestaponi, Abasha, Khobi, Senaki, Ozurgeti, Kareli, Tetritskaro, Tsalka, Bolnisi, Akhaltsikhe-Aspindza, Likani-Tsagveri, Dusheti, Tsnori, Sighnaghi; Out of abovementioned projects the works completed in Oni and Gurjaani, works are still ongoing in other sites; Engineering supervision service has been provided for the construction and rehabilitation works under the scope of European Investment Bank financed Projects.
  - Supporting Sustainable Wastewater Management (SIDA) 25 04 04

Abovementioned Project had been started since 2014 and the following activities were conducted during 2015: preparation of feasibility study for wastewater treatment plant rehabilitation in Telavi and developing technical specifications for treatment plant in Tskaltubo and Telavi; preparing environmental impact assessment for wastewater treatment plant in Telavi and Tskaltubo.

• Urban Services Improvement Investment Program (Water Supply and Saverage Sector) (ADB) - 25 04 05

According to the contracts, the works have been executed in Mestia Municipality, Anaklia, Kutaisi and Poti and the main purpose was to arrange water supply system. The contract has been signed for construction works of Ureki water supply and wastewater system.

### • Support for internally displaced persons –(25 05)

During the reporting period the following activities have been implemented under the subproject: In Poti, suburb of Maltakva, external hydro and thermal insulation has been made for 32 buildings od Internally Displaced People; Construction of 10 buildings and external engineering infrastructure, rehabilitation of surrounding of the territory for IDP in Zugdidi City; Additional Rehabilitation Works: in Tskaltubo, former sanatorium building "Elektro Meurneoba," in Kutaisi - former building for musical boarding-house and in Poti former boarding house "Aieti;" Construction of offices for supporting IDP integration process in Kutaisi, Poti and Zugdidi; taking respective measures for IDP social-economic integration; procurement of buildings for IDP resettlement in the long term; providing engineering supervision service for rehabilitation works of buildings for IDP in the western Georgia; Operational costs have been made for purchasing equipment and necessary technics under the scope of project; implementing the works associated with improving sanitary and living conditions, water supply system and drainage system for 3 cottage type settlements in Mtsketa-Mtianeti and Shida Kartli (Frezeti, Mokhisi, Tsilkani). The partial rehabilitation works in 6 collective centers of IDP have been implemented in Imereti and Samegrelo-Zemo Svaneti Regions; Rehabilitation of irrigation system in Tiriponi and Saltvisi; Rehabilitation of former hospital to turn into building for IDP in Kutaisi; preparation of design, tender documentation and supervision service for rehabilitating 8 hospitals for IDP to live in; preparation of project and tender documentation and consultancy service to build 28 collective center for IDPs; providing consultancy service for rehabilitation works in 6 former hospitals and 22 collective centers to arrange buildings for IDP; other consultancy and supervision service for arranging buildings for IDP to residency.

### • Improvement of Penitentiary Insfrastructure and create of industrial zones -(27 02 01 02)

- Ongoing repairing works of separate buildings and rooms have been accomplished in the 15 institutions of Penitentiary System; among of them: existing barber's shop has been repaired in the yard of 3 institutions, rehabilitation of the yard of new administration building and adapted infrastructure for people with special needs has been made in 2 institutions; also infrastructure for industrial zone in N16 institution was started in 2014 and finished successfully. Guard Cabin has been built in Batumi. At three institutions of Penitentiary System, all necessary infrastructures have been made for psych-social rehabilitation center "Atlantis." The works to build a new institution in Laituri are in progress, which started in summer of 2012. Designing and engineering works are in progress to build new complex for 14-21 year old prisoners.
- Provide Educational institutions with the information communication technologies -(32 05 01 02)

• 6594 units of computers have been purchased which handed to 569 public schools.

## • Development Infrastructure of Educational Institutes –(32 05 02)

- New public schools were constructed in Bughasheni and Zeda Vani and different rehabilitation works have been carried out in 507 public schools.
- The works have been implemented to arrange medical room in 187 public schools; also, medical equipment has been purchased and handed to 190 public schools.

- In accordance with Government Decree, regarding "Required activities for supply of Natural gas for residents in Georgia", designing and construction works were in progress in the following municipalities: Lagodekhi, Kareli, Kaspi, Oni, Dusheti, Ozurgeti, Tkibuli, Tskaltubo, Zestafoni, Abasha and Zugdidi. For the implementation of the mentioned works, transferred 20 millionin to budget LTD "Georgian Gas Transportation Company". As a result of the program gasified 58 settlements. In addition, completed connection works to the gas pipeline of the consumers at 60 settlements what is at the demarcation line of the occupied territory. Natural gas is accessible for 12 672 consumer.
- During the reporting period completed electrification works. The following villages electric supply and associated electric infrastructure was taken under exploitation after the program: village Noja, Koshkaskheli (Tsobano), Nojiketi, lower and upper Gharistskhali, Chonto and Moliani settlement (Natanebi). Completed electric supply lines construction works and expertise work was in progress for the village Lelubani in Mtskheta municipality and village Ekseliseebi (Shrosha) in estaponi Municipality.
- Electric supply infrastructure arrangement was consider for the following villages in Lentekhi municipalities: Bavari, Mananauri, Tsrumaldi, Khacheshi, but electric supply lines construction works contract terminated due to non-compliance with the supplier's contractual obligations and the legislation passed by the appropriate measures. Baghdadi Municipality signed contracts for the provision of electricity supply of the villagers.

Now is running initial electric devices production works.

excavation works.

Exchange of Power transformer at "Menji 220/110kw" sub-station \_ it is submitted and agreed with employer arrangement design of basement for the auto-transformer. Currently running preparation works for dismantle #1 auto-transformer. Detail design is received and under discussion detail plan and working schedule. As well stuff agreement and approval is under agreement process.

- 500/220kw sub-station construction in Jvari Completed installation works of 220 kw devices and now is running the works for 500 kw devices, at the same time is running installation of metal-construction. Completed works for control building framework and façade, now is running internal works. The reactors are placed on site. Now is running drainage system arrangement. Completed power transformers manufactural testify. Partly undertaken transformer installation at the territory of sub-station. Now was running marking lines for grounding.
- 220kw electric transfer line construction sub-station "Jvari" sub-station "Khorga" (60kw) and existence electric transfer line "Caucasioni" interapt in the sub-station "Jvari" (8km) there is submitted 99% of the design, it is discussed and agreed. Proceed 220kw and 500kw electric transfer lines basements arrangement. Permission regarding displace the trees is already received, except the trees included in the Red Book. There was running access road construction works for 220kw electric transfer line construction.

Detail designing was in progress, as well survey and preparation works of construction territory. Settlement acting plan one part is approved and continues work for another three plan.
