Chapter III

State Budget Allocations

In 2015 year by the Georgian law about " 2015 State Budget of Georgia " was amended twice. In total, the state budget allocations compared to the initial budget increased by 45 000.0 thousand GEL and was determined with 9 620 000.0 thousand GEL.

Cash execution of the reporting period amounted to 9 703 127.1 thousand GEL, which in relation of the planned figure is more than 83 127.1 thousand GEL, it is 100.9% of the the planned figure.

State Budget Expenditures

By the Georgian law about " 2015 State Budget of Georgia" the expenditures of state budget was detirmed by 8 110 493.1 thousand GEL. Specified plan amounted to 8 090 303.2 thousand GEL which is 99.8% of the

approved annual rate. Cash expenditures amounted to 8 157 998.4 thousand GEL, which is 100.8% of planned figure.

The Increase of Non-Financial Assets of the State Budget


By the Georgian law about " 2015 State Budget of Georgia" defined the increase of non-financial assets with 699 093.9 thousand GEL. The specified plan amounted to 680 985.0 thousand GEL, which is 97.4% of the annual approved figure. Cash execution amounted to 680 173.3 thousand GEL, which is 99.9% of planned figure.

The Increase of Financial Assets of the State Budget

By the Georgian law about "2015 State Budget of Georgia" the increase of financial assets was determined with 336 190.0 thousands Gel. The specified plan amounted to 428 506.0 thousand GEL, which is 127.4% of the approved annual rate. Cash execution amounted to 444 804.8 thousand GEL, which is 103.8% of planned figure.

Decrease of the State Budget Liabilities

By the Georgian law about "2015 State Budget of Georgia" the decrease of the state budget liabilities was defined with 474 223.0 thousand GEL. The specified plan amounted to 420 205.9 thousand GEL, which is 88.6% of the annual approved budget. Cash execution amounted to 420 150.6 thousand GEL, which is 100.0% of the planned figure.



Within the allocations were completed the following measures:

in the pension provision, for the purpose of financing the state's obligations "State Pensions" and "On State Compensation and State Academic Scholarship" of beneficiaries under domestic law to ensure the state pensions and state compensation. Since September 2015, the annual budget law, and increased the amount of the pension amounted to 160 GEL. January 1, 2015 to 500 Gel and determined for each family 1 000. International operations or other peacekeeping activities of the deceased or the missions of health damage due to the death of the Georgian Ministry of Defense personnel, family members, as well as the territorial integrity, freedom and independence, as well as 1998, May 2004 and in August, who died of their wounds or deaths due to be issued to family members of the compensation amount. During the reporting period, the pension provision of software code from the transfer of 1 399.0 mln Gel.

- Within the frameworks of social assistance program in the country was carried out a social assistance to vulnerable families in the database of registered poor families and reintegration assistance of return of children from the institutions to their biological families. Also, social assistance funding for disabled persons, disabled children, without content and other vulnerable categories of refugees and IDPs allowances provision and labor duties of the employee's person's health as a result of damages caused, during pregnancy, childbirth and child care, adoption assistance, household subsidies, within the frameworks of the state target program of improvment the demographic situation, the cash assistance for the third and each subsequent birth of a child. In respect of the issuance social aid for target groups of the population in the reporting period, was allocated 1 156.5 million GEL;
- The aim of "the Universal Healthcare Program" (fully launched in September 1, 2014) is to create a financial support availability of medical services for the health of uninsured people of Georgia, in the reporting period the state of health of emergency hospitalization and outpatient services through increased affordability was improved. The program also covered, non-emergency outpatient and inpatient services (non-emergency operations, including those of surgical oncology and cardiac surgery, cancer treatment, delivery, laboratory and instrumental examinations, etc.). Totally for this purpose during the reporting period were used 570.7 million Gel.
- From 2015 September for all persons with sharply expressed disabilities (about 25 thousand persons) was increased the amount of social assistance with 10 Gel, and for all children with limited ability status (approximately 9 200 children with disabilities) social package volume grew with 60 Gel;
- From 2015 April launched a treatment of hepatitis C with new generation of drugs, which is totally free to the citizens of Georgia. 6 000 persons have benefited from the diagnostic component. For this purpose during the reporting period was used 6 061.3 thousand Gel;
- The Ministry of Defence, the Ministry of Internal Affairs and the Ministry of Corrections and Legal Assistance have financed the insurance premiums for their employees;
- Providing of the facilities for refugees of the former collective accommodation in private ownership which were under the control of the state was carried out, within the frames of this private ownership of residential property (apartment) was checked 857 facilities and described 7990 families. Apartmanets were transferred in the ownership to 5 575 families; for the purpose of long-term accommodation development and imporvment of living conditions 1 328 IDP families were provided accommodation, 14 parts of the house were purchased totally 268 apartments and 440 living house in the different regions of Georgia and Tbilisi.

In addition, in the framework of IDP support program the Ministry of Regional Development and Infrastructure allocated 55.8 million, mainly spent in respect of the following:

- ✓ In Zugdidi, on improving the area as well as external engineering infrastructure for 10 apartment buildings in the residential area for internally displaced persons;
- ✓ For the arrangement of hydro and thermal insulation of outside of 32 residential building for IDPs in Poti, Maltakva district.
- ✓ Partial rehabilitation works for 6 IDP collective centers in Imereti and Samegrelo-Upper Svaneti regions.
- As a social benefit, financial assistance was provided to 3 817 refugees, as well as 851 families living in extreme poverty for the rental purposes of living spaces (the amount of 200 to 300 Gel);
- To assist in financing assistance and reconstruction to the families effected by the disaster on June 13-14 in Tbilisi from the government's reserve fund and the president's fund and the reserve funds directed 35.0 million GEL for the regional projects.
- Within the framework of the successfully completed reform"Transfer from analogue to digital terrestrial broadcasting system in Georgia" 70 000 and less than a rating score of socially vulnerable families (including people with disabilities or their families) were equiped with the digital terrestrial signal receiving certified equipment (the so-called Set Top Boxes);
- About 430.0 mln Gel was allocated in respect with for school finance more than 2.0 thousand public and up to 300 private schools
- More than 6.5 computers have been purchased, which were given to six hundred public schools for its classroom and rooms. As well as more than 1.9 thousand computers were purchased and about 45.0 thousand units portable computers for the first grade pupils and their teachers;
- In order to ensure safety pupils / students, 1 170 security officers were employed in the educational establishments, distributed among 419 public and 3 private schools, in 2 professional shools and 1 university. For this purpose, more than 11.2 million was allocated in respect of this.
- For the teachers living in the conflict zones and administrative- technical personnel have been provided with financial assistance, in respect of 2.3 million Gel.
- 64.0 thousand students of 1 143 thousand public school havw been provided with free transportation to school, who live in urban areas, where there is no school and to the school the distance is far, 16.8 million Gel was allocated in respect of this.
- construction of two public schools, 507 public schools and 12 vocational colleges in different types of rehabilitation have been completed. Also, funding has been given to 204 educational institutions, for the purpose of rehabilitation implementation;
- In the frameworks of "Sportsmen's Scholarship" program 750 athletes, coaches and medical personnel were awarded with scholarships. In the frameworks of "Veteran Sportsmen and Sport Workers Social Aid" program to improve social and material conditions 360 veterans and sports personnel received assistance. In the frameworks of "Olympic champions scholarship" program scholarship has been appointed to 32 famous athletes, 1 000 Gel for each of them;
- In the framework of the sport support, about 130 local sport competitions and 200 training meetings were funded in 45 types of sport. Georgian athletes participated about 170 international sports competition and won 679 medals (200 gold, 200 silver and 279 bronze). According to the achieved results in sports individual Olympic, non-Olympic, Paralympic sport and certain kinds of sport competitions, by the cash prizes were awarded the team members, coaches, medical personnel and the national sports federations of groups, for which

in the reporting period, from the government's reserve fund allocated 10.6 million Gel in accordance with the resolution of the government of Georgia - "state promotion program for Georgian sportsmen".

- Necessary activites were carried out for arranging the infrastructure for the European Youth Olympic Festival in 2015 (including building a multi-functional sports palace and a swimming pool) financing the necessary arrangements, in the reporting period from the reserve funds of Georgia and projects which are to be implemented in the regions of Georgia, by the government's decision acts' released allocations amounted to 72.6 million;
- In the frameworks of sports infrastructure and infrastructure renewal program local municipalities of Georgia were provided with sport inventories with low value. A special equipment for mountaineering federation was purchased;
- The program providing with housing, meals and sports gyms to 150 athletes registered in the LEPL Olympic reserve team, including the Georgian national team members and candidates has been implemented;
- The consumed 10.6 million m3 of natural gas, which cost 4.3 million GEL was compensated for a permanent resident population in Kazbegi and Dusheti Municipality and Municipal mountainous villages (Seturi, Zakatkari, Jaghmiani, Bedoni, Bego, Benian-Bego, Iukho, Muduru, Tskere, Tsikhiani, Sviana-Rostiani and Korogho).
- During the reporting period, 46.0 million was allocated to farmers in respect of spring work promotion, with 4.8 million Gel- funding agricultural insurance;
- For purpose of implementing 2015 harves effectively, in particulat for supporting purchasing-processing grapes was allocated 60.7 million Gel;
- During the reporting period, wine processing companies proived by 148.3 thousand tons of grapes, of which the number of subsidized grapes amounted to 122.3 thousand tons, including: 35.5 thousand tons of grapes of Saperavi, 84.9 thousand tons of Rkaciteli, 84.9 thousand tons of Rkaciteli, 1.9 thousand tons of Kakhuri mtsvane;
- According to the National Wine Agency, in the reporting period, Georgia exported to 46 countries around the world about 36 071.4 thousand bottles (0.75 liters) of wine, which amounts 98.1 million US dollars. Export growth is distinguished in the strategically important markets such as the US, Canada, Japan, exports also increased in Kyrgyzstan, Israel, Korea, and others, as well as an increase in the EU countries: Poland, Lithuania, Estonia, the Netherlands, France and Denmark. Export revenue of wine, brandy, chacha, wine material, draft brandy and spirits for brandy amounted to 146.5 million US dollars;
- In respect of the modernization of irrigation systems was allocated 63.5 million Gel, including the following: for the purpose of rehabiliation of irrigation infrastructure and in order to purchase irrigation techniques 53.5 million Gel, current operating costs of irrigation infrastructure and for the partial subsidy of the current expenses 10.0 million Gel.
- On the activities for developing road infrastructure, road maintenance, new motorways, secondary and local roads and on the construction 488.4 million Gel has been spent, including:
 - ✓ Periodic road maintenance and rehabilitation 110.8 million Gel.
 - \checkmark The repair and maintenance of roads in the winter period 38.9 million Gel
 - ✓ Construction of the Express highways 257.3 million Gel.
- LEPL Municipal Development Fund spent 183.9 million Gel on municipal infrastructure development including:
 - ✓ Sustainable urban transport investment program 92.8 million Gel;

- ✓ Regional Development Project Part I (Kakheti) 9.4 million Gel;
- ✓ Part II Regional Development Project (Imereti) 16.5 million Gel;
- For purpose of water-related infrastructure projects was allocated 137.5 Million Gel, including the following:
 - ✓ water infrastructure renewal (I and II) 34.0 million Gel;
 - ✓ improvement of urban services 88.6 million Gel;
- For bulding of ski lift and mountain infrastructure, under the direction of it in upper Svaneti was allocated 21.0 million Gel, and for the reconstruction and rehabilitation of the Chiatura ski lift 5.6 million Gel;
- In order to involve in state property economic, activity state agencies / legal entities, were transferred 447 pieces of real estate, and the self-governing units 1 195 units;
- Within the program "Produce in Georgia", during the reporting period by the Enterprise Development Agency, signed a contract with the 64 beneficiary companies for the purpose of co-financing the interest rate. The total number of approved loans amounted to 97.3 million Gel, and an expected investment 147.1 million Gel. In addition, the program of infrastructure support component of the property was transferred to the 21 beneficiaries;
- The first technology park of Georgia was completed, 5 laboratories of industrial innovation (Batumi, Kutaisi and Tbilisi) was created, Innovation Center in Gori (at the central base of Gori) which will contribute to the establishment of an innovative ecosystem, innovation and technology development;
- The Embassy of the Republic was opened in Cuba. diplomatic relations was established with the Kingdom of Tonga, Belize and Namibia. Coverage area of embassies was increased. 105 bilateral and multilateral cooperation agreements were signed / entered into force. Of the annual membership fee has been paid by various international organizations, foundations and international organizations within the United Nations peacekeeping mission.
- The agreement with Belaurs, Portugal, Iceland, and Germany on income and on the avoidance of double taxation entered into force was signed; The agreement with Cyprus on income and on the avoidance of double taxation entered into force, the agreement with Likhtenstein was signed; Agreement texts were initialed with South Korea, Sudi Arabia and Maroco, the agreement was renewed with Poland.
- "About the measures of the government of Georgia towards the debt payment to the National Bank of Georgia" according to the amendments to the agreement signed in the March 20, 2006 between the government and the National Bank" in 2015 on March 15, was carried out the upgrade of 400,846.0 thousand GEL issued by the government in 2014 on March 15 worth,846.0 thousand Gel, with paying annual interest 5.919 percent and for the assignment of 40,000.0 thousand Gel into government bonds in the open market operations, including:
 - ✓ 10,000.0 thousand Gel by payment 8.000 percent annual interest.
 - ✓ 8,000.0 thousand Gel by payment 8.250 percent annual interest;
 - ✓ 12,000.0 thousand Gel by payment 8.625 percent annual interest;
 - ✓ 10,000.0 thousand Gel by payment 9.125 percent annual interest.

Also, the above-mentioned Agreement, 2015 on March 15, was carried out on 15 March 2010 with the release of "bonds in the open market" covering 5,000.0 thousand Gel and 2015 on June 15, took place on 15 March 2011 with the release of "bonds in the open market" covering 10,000.0 thousand GEL, 2015 September 15 was carried out on 15 March 2012 with the release of "bonds in the open market" to repay the amount of

12,000.0 thousand on December 15, 2015 and March 15, 2013 was carried out "on the bonds in the open market" to repay the amount of 8,000.0 thousand.

• During the reporting period, the state awards monetary prizes were issued to 125 persons. 87.6 thousand Gel was allocated for this purpose.

State Budget Expenditures by Economic Classification

By the article of **"labor compensation"** in the reporting period, the adjusted plan has been set with 1 378 765.0 thousand GEL, and execution of the cash amounted to 1 376 776.9 thousand GEL, which is 99.9% of the planned figure. Cash execution of "labor compensation" is 16.9% of the "costs" of cash performance and 14.2% of the state budget taxes.

By the article of "goods and services" in the reporting period, the adjusted plan has been defined with 917 475.8 thousand GEL. Cash execution amounted to 946 218.8 thousand GEL, which is 103.1 % of the plan. Cash execution of "Goods and Services" is 11.6% cash performance of "costs" and 9.8 % of the state budget taxes.

From the category "Goods and Services" according to the economic classification articles the rest of the cost structure is as follows:

- Contracted workers' compensation 149 844.9 thousand GEL;
- Business trips 63 083.9 thousand GEL;
- Office expenses 179 812.0 thousand GEL;
- Representative Expenses 17 877.0 thousand GEL;
- Food costs 67 844.7 thousand GEL;
- Medical costs 34 334.5 thousand GEL;
- Soft inventory, uniform and personal hygiene-related costs 29 716.5 thousand GEL;
- Vehicles, equipment and weapons operation and maintenance costs 120 800.5 thousand GEL;
- Military equipment and ammunition acquisition costs 32 050.5 thousand GEL;
- Other goods and services 250 854.3 thousand GEL.

By the article of **"Interest"** in the reporting period, the cash execution amounted to 326 591.3 thousand Gel (99.9% of the adjusted plan), which is 3.4 % of the state budget expenditures. Percent of the foreign debt service was directed to 174 293.8 thousand GEL, while the domestic debt service was directed to 152 223.7 thousand GEL.

By the article of **"Subsidies"** in the reporting period, the adjusted plan 235 626.4 thousand Gel And cash execution amounted to 245 745.2 thousand GEL, which is 104.3 % of the plan, while the state budget expenditures 3.0% of the total.

From the article of "Subsidies" mainly were financed such important programs, such as:

- ✓ Sports development supporting events 56 097.0 thousand GEL was allocated in respect of the events organized by the Minister of Sport and Youth Affairs during the reporting period, which is 99.9% of the planned figure;
- ✓ 34 209.6 thousand Gel was allocated to discounted agro-credit program, which is 96.4 % of the planned figure;
- ✓ promotion of science and research 18 688.6 thousand GEL in total was allocated for it, which is 99.5% of the planned figure;

- ✓ theological education assistance grant for the respect of 14 490.6 thousand GEL, which is 100.0% of the planned figure;
- ✓ modernization of irrigation systems 10 000.0 thousand GEL in total for allocated for this, which is 100.0% of the planned figure;

By the article of **"Grants"** in the reporting period, the cash execution amounted to 1 271 342.9 thousand GEL, which is 99.6% (1 271 342.9 thousand GEL) of the adjusted for planned indicator and 13.1 % of the state budget expenditures.

By the article of **"social welfare"** in the reporting period, the cash execution amounted to 2 802 402.0 thousand GEL, which is 100.0 % (2 801 988.1 thousand GEL) of adjusted planned parameters and 34.4% of the state budget expenditures

From the article of social welfare were financed important measures, such as:

- ✓ Providing pension for the population 1 398 957.0 thousand Gel was allocated in the respect of it, which is 100.0% of the planned figure;
- ✓ Ensuring Universal Public Healthcare 611 837.4 thousand Gel was allocated in respect of it, which is 100.0% of the planned figure;
- ✓ Social assistance of the targeted groups of population 570 681.9 thousand Gel was allocated in respect of it, which is 100.0% % of the planned figure;
- ✓ Ensuring public healthcare and the provision of health care delivery programs in the priority areas 155 658,8 thousand Gel was allocated in total inrespect of it, which is 100.3% of the planned figure;
- ✓ Social rehabilitation and child care 17 804.5 thousand Gel was allocated in respect of it, which is 99.8%-of the planned figure;

By the article of **"other expenses"** in the reporting period specified plan was allocated to 1 153 166.4 thousand Gel, while the cash cost incurred at 1 188 921.3 thousand Gel which is 103.1 % of the plan. The cash performance of "other expenses" is 14.6% of the cash performance of "expenses" while it is 12.3% of the state budget expenditures.


From the article of "other expenses" were financed important measures, such as:

- The state studying, master grants to encourage young people 73 628.9 7 thousand Gel was allocated in respect of it, which is 153.7 % of the planned figure;
- spring support measures of farmers 46 000.0 thousand Gel was allocated in respect of it, which is 100.0 % of planned figure;
- restoration and rehabilitation of water supply infrastructure 34 460.9 thousand Gel was allocated in respect of it, which is 99.7% of the planned figure;
- For the purpose of developing educational and scientific institutions' infrastructure was allocated 32 110.4 Gel, which is 99.6 % of the planned figure
- Millenium challenge to Georgia (MCG) 29 901.6 thousand GEL was allocated in respect of it, which is 70.0% of the planned figure;

- Support of science and scientific researches for this purpose was allocated 26 732.6 thousand Gel, which is 104.2 % of the planned figure;
- For improvement professional education availability anf quality for this purpose was allocated 14 789.1 thousand Gel, which is 99.8 % of the planned figure;
- Financing political parties and none-governmental sector for this purpose was allocated 12 152.2 thousand Gel, which is 99.1 % of the planned figure;


The structure of 9-month allocations of 2016

According to the main functional categories the structure of the performance of 2015 state budget is characterized by:

- 2 049 822.1 thousand GEL was planned to finance general government services sector. Cash execution amounted to 2 050 259.0 thousand Gel, 100.0 % of the planned figure, while total costs and 23.2% of non-cash increase performance, including the followings:
 - ✓ funding the activities of executive and representative bodies, financial and fiscal activities, external relations, amounted to 367 957.8 thousand GEL, which is 100.0%(367 957.8 thousand GEL) of the plan;
 - ✓ general-purpose service funding amounted to 40 963.6 thousand GEL, which is 107.3% (40 963.6 thousand GEL) of the plan;
 - ✓ funding fundamental scientific research amounted to 37 083.5 thousand GEL, which is (34 706.8 thousand GEL) 106.8% of the plan;
 - ✓ general cash flow between different levels of government funding amounted to 326 517.5 thousand, which is 99.9%(326 517.5 thousand GEL) of the plan;
 - ✓ general cash flow between different levels of government funding amounted to 1 242 414.8 thousand, which is 99.6%(1 242 414.8 thousand GEL) of the plan;



- in the field of public order and safety 963 502.0 thousand GEL was allocated. Cash execution amounted to 961 032.9 thousand, 99.7 % of the planned figure, while total costs and non-financial asset increases cash performance 10.9%. including the following:
 - ✓ Police Service and the State funding amounted to 650 339.1 thousand GEL, the 100.3 % (648 688.1 thousand GEL) of the plan;
 - ✓ Fire department service funding amounted to 15 128.9 thousand GEL, 100.0 % (15 134.2 thousand GEL) of the plan;
 - ✓ the courts and the prosecutor's funding amounted to 107 852.0 thousand GEL, which is 99.2% (108 769.0 thousand GEL) of the the plan;
 - ✓ provided funding for penal institutions amounted to 117 722.5 thousand GEL, which is 97.9% (120 243.5 thousand GEL) of the the plan;
 - in the field of the public order and safety funding of the other non-classified activities appropriations amounted to 69 990.4 thousand GEL, which is 99.0 % (70 667.2 GEL) of the plan.
 - For funding economic activities 944 304.6 thousand GEL was planned, while the cash execution amounted to 950 249.7 thousand GEL, the 100.6% of the planned figure, 10.8% of the total costs and non-financial asset increase cash performance, including the following:
 - ✓ funding of the overall economic, commercial and labor-related activities amounted to 43 524.2 thousand GEL, the 99.3 % of (43 842.3 thousand Gel) of the planned figure;
 - ✓ Funding of agriculture, forestry, fisheries and hunting amounted to 201 031.9 thousand GEL, which is 101.6 % (197 784.7 thousand GEL) of the plan;
 - ✓ Funding spent on fuel and energy amounted to 23 664.4 thousand GEL, which is 187.6% of the the plan (12 614.7 thousand GEL);
 - ✓ For funding mining and mineral processing industry and construction was directed 1 406.8 thousand GEL, 98.8% (1 423.3 thousand) of the plan;
 - ✓ transport funding amounted to 568 642.6 thousand GEL, the 98.8% of (575 792.1 thousand GEL) the plan;
 - ✓ funding of other economic sectors amounted to 81 769.9 thousand GEL, 97.6 % of (83 749.9 thousand GEL) the plan;

- ✓ funding of economic activities in the area and other unclassified appropriations amounted to 20 525.0 thousand GEL, which is 92.2% (22 256.1 thousand GEL) of the plan;
- ✓ Funding the research applied in economic activity amounted to 1 030.1thousand Gel which is 100.0 % (1030.2 thousand Gel) of the planned figure;

The Reserve Fund of the Government of Georgia

By the law of Georgia about "The 2015 state budget" government's reserve fund allocations were determined by 85 000.0 thousand Gel.

In addition, the Section 4 of Article 31 of the Budget Code and on the basis of Article 23 of " 2015 State Budget" were made decisions in various spending agencies allocations to the amount of the distribution of the state fees and the reserve fund was increased by 27 188.0 thousand Gel.

Also, provided allocations for foreign and domestic debt service and payment (total 52 200.0 thousand Gel), in previous years the debt payment and execution of court decisions appropriations (5 300.0 thousand Gel) and the state awards for monetary bonuses funding allocations (410.0 thousand Gel) at the expense of the reserve fund was increased by 57 910.0 thousand Gel. Therefore, the total appropriations for the year were increased by 85 098.0 thousand Gel and at the end of the year was determined with 170 098.0 thousand Gel.

During the reporting period, by the government resolutions and orders of the Prime Minister of Georgia allocations released from the government's reserve fund amounted to 170 012.9 thousand GEL, and cash performance - 167 943.9 thousand GEL.





The structure of the state securities balance For the end of the reporting period




