

Chapter III

State Budget Allocations

By the law of Georgia "about the 2016 state budget of Georgia" the state budget payments ware defined with 10 145 000.0 thousand GEL. From the mentioned amounts the funds allocated in the reporting period amounted to 7 629 628.3 thousand GEL, which is 75.2% of the annual budget. Cash execution amounted to 7 340 609.3 thousand GEL, which is 96.2% of the planned figure.





State Budget Expenditures

By the law of Georgia "about the 2016 state budget of Georgia" the state budget payments ware defined with 10 145 000.0 thousand GEL. From the mentioned amounts the funds allocated in the reporting period amounted to 7 629 628.3 thousand GEL, which is 75.2% of the annual budget. Cash execution amounted to 7 340 609.3 thousand GEL, which is 96.2% of the planned figure.

The Increase of Non-Financial Asset of the State Budget


By the law of Georgia "about the 2016 state budget of Georgia" "the increase in non-financial assets was defined with 750 071.9 thousand GEL. From the mentioned amounts the funds allocated in the reporting period amounted to 540 062.1 thousand GEL, which is 72.0% of the approved annual rate. Cash execution amounted to 442 849.9 thousand GEL, which is 82.0% of the planned figure.

The Increase of the Financial Asset of the State Budget

By the law of Georgia "about the 2016 state budget of Georgia" "the increase in financial assets was defined to 407 001.6 thousand GEL. From the mentioned amounts the funds allocated in the reporting period amounted to 307 178.9 thousand GEL, which is 75.5% of the approved annual rate. Cash execution amounted to 347 069.9 thousand GEL, which is 113.0% of the planned figure.

The Decrease of Liabilities of the State Budget

By the law of Georgia "about the 2016 state budget of Georgia" "the decrease of the liabilities of the statge budget was defined to 444 357.0 thousand GEL. From the mentioned amounts the funds allocated in the reporting period amounted to 303 378.9 thousand GEL, which is 68.3% of the annual budget. Cash execution amounted to 294 745.0 thousand GEL, which is 97.2% of the planned figure.



Within the allocations, the following measures were completed in the reporting period:

- In the pension, provision for financing the state's obligations by the Georgian law about "the State Pension" and "State Compensation and State Academic Scholarship" beneficiaries were ensures with the state pensions and state compensation. In July of the current year, the pension defined according to the retirement age was increased, in particular for all pensioners pension was determined by the amount of GEL 180. During the reporting period, from the software code of pension provision was transferred 1 153.1 million GEL.
- Within the frameworks of social assistance program in the country was carried out a social assistance to vulnerable families in the database of registered poor families and reintegration assistance of return of children from the institutions to their biological families. Also, social assistance funding for disabled persons, disabled children, without content and other vulnerable categories of refugees and IDPs allowances provision and labor duties of the employee's person's health as a result of damages caused, during pregnancy, childbirth and child care, adoption assistance, household subsidies, within the frameworks of the state target program of improvment the demographic situation, the cash assistance for the third and each subsequent birth of a child, (January 1, 2016 beneficiaries get financial assistance, whose one of the parents has a permanent resident status in the highland settlement). In respect of the issuance social aid for target groups of the population in the reporting period, was allocated 482.9 million GEL;
- The aim of "the Universal Healthcare Program" (fully launched in September 1, 2014) is to create a financial support availability of medical services for the health of uninsured people of Georgia, in the reporting period the state of health of emergency hospitalization and outpatient services through increased affordability was improved. The program also covered, non-emergency outpatient and inpatient services (non-emergency operations, including those of surgical oncology and cardiac surgery, cancer treatment, delivery, laboratory and instrumental examinations, etc.). Totally for this purpose during the reporting period were used 492.3 million GEL
- From September the benefits provided by the law about "the development of mountainous regions of Georgia" entered into force, namely: pensioners living in the mountainous settlement will receive a pension supplement of 20%, as well as the social package of 20% has been called for social assistance recipients. Within the frameworks of the program in September: about 51.5 thousand persons received the state pension supplement, while 10.1 more persons received the social package plug;
- The Ministry of Defence, the Ministry of Internal Affairs and the Ministry of Corrections and Legal Assistance have financed the insurance premiums for their employees;
- Providing of the facilities for refugees of the former collective accommodation in private ownership which were under the control of the state was carried out, within the frames of this private ownership of residential property (apartment) was given to 1 513 families, for the purpose of long-term housing and improve the living conditions of refugees 537 houses have been purchased in Tbilisi and in other regions. 51 apartments was redempted from the private-owned houses, and for the disaster-affected families 82 houses have been purchased in different regions. The purchase of housing in Tbilisi and Kutaisi was done in 5 sites, the purchase of apartments of the 6 sites was in process in different cities. The building of residential buildings on the three sites was underway. Building construction and rehabilitation works of the 3 sites was completed, while it was underway for 5 accommodation facilities;

• For the purpose of urgent rehabilitation of housing, infrastructure and in order to improve, the financial opportunities Ministry of Regional Development and Infrastructure Ministry- the Municipal Development Fund of IDPs allocated 23.3 million Gel.

• For the purpose of renting appartments (the amount of 200 to 300 GEL) as a social assistance, financial assistance was provided to 4 742 refugees, as well as for 1 425 destitute families from various building which are in ruins.

• State Property Agency provided the real estate to 2 394 displaced families, while 407 real estates were given to the families of migrants;

• 377.0 million Gel was allocated in respect to finance two thousand public and 240 private secondary schools;

• 70.0 thousand students of 1.2 thousand public school has been provided with free transportation to school, who live in urban areas, where there is no school and to the school the distance is far, 10.2 million Gel was allocated in respect of this.

• For the teachers living in the conflict zones and administrative- technical personnel have been provided with financial assistance, in respect of 1.8 million Gel.

• 1 300 security officers in the educational institution territory ensured public order and safety. Security officers were distributed to 450 schools, 3 professional institutions and one university;

• The construction of 180 public schools and the different types of rehabilitation works in nine professional training centers completed in Iormughanlo, Sagarejo municipality. Design and estimate documentation for 350 schools and construction and rehabilitation projects have been prepared, in the purpose of the implementation of the rehabilitation 138 public schools and 5 higher education institutions were funded. Also, 12 public schools rehabilitation, tender procedures for 13 public schools and biological cleaning equipment have been installed for 13 schools, in purpose of implementing some projects 10 professional educational centers were funded.

• The Government of Georgia has initiated and supported a large-scale project "Check in Georgia", which includes a series of cultural events in Tbilisi and regions. The goal of the project is to create the country as the center of culture and attract tourists. For this purpose 27.8 million Gel was allocated.

• the cultural heritage assessment, rehabilitation of monuments / conservation project documentation preparation and implementation of the reconstruction was supported;

• In the frameworks of "Sportsmen's Scholarship" program 700 athletes, coaches and medical personnel were awarded with scholarships. In the frameworks of "Veteran Sportsmen and Sport Workers Social Aid" program to improve social and material conditions 402 veterans and sports personnel received assistance. In the frameworks of "Olympic champions scholarship" program scholarship has been appointed to 32 famous athletes, 1 000 Gel for each of them;

• In the framework of the sport support, about 175 local sport competitions and 230 training meetings were funded in 48 types of sport. Georgian athletes participated about 150 international sports competition and won 570 medals (197 gold, 167 silver and 206 bronze);

• In the frameworks of sports infrastructure and infrastructure renewal program launched a project that provides exercise device installation for 24 regions of Georgia. During the reporting period, 22 units of the outdoor exercise equipment have been installed, as well as for sports facilities variety of sports equipment had been transferred to the national sports federations and local authorities.

• The program providing with housing, meals and sports gyms to 150 athletes registered in the LEPL Olympic reserve team, including the Georgian national team members and candidates has been implemented;

• "Youth Festival 2016" was held within the multi genre Festival - "Fan ART", which support to show young gifted people (age of participants - 15-29) in 10 directions of Art (copyright or improvised classical music, painting, sculpture, film / animation, photography, social media, rock / alternative music, literature, folklore, stenciling);

• The consumed 7.7 million m3 of natural gas in 2015, the first from December 2016 through May 15, which cost 3.1 million GEL was compensated for a permanent resident population (4.3 per thousand subscribers) in Kazbegi Municipality and Municipal mountainous villages (Seturi, Zakatkari, Jaghmiani, Bedoni, Bego, Benian-Bego, Iukho, Muduru, Tskere, Tsikhiani, Sviana-Rostiani and Korogho, as well as in the villages, which according to the legislation granted the status of mountainous settlement.

• For rehabilitation of irrigation and drainage systems, construction of reservoirs, reclamation purpose machinery, machine tools, equipment, machinery, and the purchase of vehicles, maintenance of irrigation infrastructure in operation, pumping stations and other hydro-system operation manual for use of electricity, the reclamation of the destination equipment, vehicles and other machine- mechanisms of maintenance activities in respect of the partial subsidy was allocated 28.0 million Gel;

• Within the discounted agro-credit project, employers are provided cheap and available funds, relevantly the agency is providing co-financing of the loan interest rate issued by the participating commercial banks and financial institutions, on the bases of fixed interest rate. During the reporting period 627 loans - 30.8 million dollars and 497 - 24.3 million GEL. Total co-financing interest rates of the loans amounted to 37.1 million Gel;

• Within the supportive program of 2016 Spring works, the plowed land area amounted to 201.4 thousand hectares, for which 49.8 million Gel was spent for stimulating land-poor farmers engaged in agricultural activities.

• Within the framework of providing agricultural insurance activities, the insured crop amounted to 122.9 million Gel, while the insured area - 14 307 hectares. Within the program 3.6 million Gel was paid.

• On the activities for developing road infrastructure, road maintenance, new motorways, secondary and local roads and on the construction 355.9 million Gel has been spent, including:

- ✓ Periodic road maintenance and rehabilitation 86.6 million Gel.
- ✓ The repair and maintenance of roads in the winter period 32.5 million Gel
- ✓ Construction of the Express highways 160.3 million Gel.
- LEPL Municipal Development Fund spent 141.7 million Gel on municipal infrastructure development including:
 - ✓ Sustainable urban transport investment program 49.3 million Gel;
 - ✓ Water-related infrastructure projects 23.0 million Gel;
 - ✓ Regional Development Project Part I (Kakheti) 8.0 million Gel;
 - ✓ Part II Regional Development Project (Imaret) 5.2 million Gel;
 - ✓ Regional Development Project III (Moschetti and Samtskhe-Javakheti) (WB) 4.8 million Gel;
 - ✓ Regional and municipal infrastructure development project II 10.7 million Gel;
 - ✓ Chiatura cable road reconstruction and rehabilitation project -11.5 million Gel;
 - ✓ Ministry of Urban Development and Reconstruction project 9.7 million Gel;
- The rehabilitation projects of the water supply infrastructure was underway and completed: in Poti reconstruction of 4 new reservoir filters, pumping stations, wells and distribution networks in the villages connected to the highway. In Kutaisi reconstruction of reservoirs and pumping stations, trunk and distribution networks was completed. In Ureki infrastructure construction of the water supply, sewage system and filteres and other facilities was completed. For financing the mentioned activities during the reporting period was directed 68.9 million Gel.
- In order to involve in the state property economic activity, state agencies / legal entities were provided 185 real estates, and the self-governing units 1 193 units;
- During the reporting period, within the "Produce in Georgia" program the following measures were carried out:

- ✓ Enterprise Development Agency signed agreements with 59 companies with the purpose of co-financing an interest rate with the beneficiary company. The planned investment which must be complemented by them is 96.9 million dollars, while the amount of loans issued from the financial institutions 53.6 million Gel (1 606 new jobs were created in addition);
- ✓ Within the frameworks of the micro and small enterprise support project 1 185 business projects were funded, from where on the stage I currently 544 projects were funded, 641 projects at the stage II. Within the second stage more than 3 700 beneficiaries were trained and retrained in business plan writing;
- ✓ Within the frameworks of program "micro-grants for mountain development" 327 business projects were funded, 2 000 beneficiaries were trained in writing a business plan.
- ✓ Within the technical support with the 2 beneficiaries of the industrial part was signed an agreement on cofinancing. In addition, training programs was held for increasing the qualification of the managers, which included the visit and training of the entrepreneurs in Germany (food products, wine production, agriculture, textile and pharmaceutical companies) as well as individual meetings with companies operating in Germany;
- ✓ "Film in Georgia" within the encourage the component of film industry, which is carried out in collaboration with the National Film Center, 5 projects were implemented, 4 of projects which have already been completed. A total investment in Georgia is 7.3 million dollars, and the total amount for qualified expenses is 5.9 million dollars. 650 people were employed within the program projects;
- ✓ Coverage area of embassies was increased and established diplomatic relations with Swaziland and Papua New Guinea. Bilateral and multilateral 56 agreements and protocols were signed and 26 agreements entered into force;
- ✓ The agreement with Cyprus on income and on the avoidance of double taxation entered into force, the agreement with South Korea was signed;
- ✓ "About the measures of the government of Georgia towards the debt payment to the National Bank of Georgia" according to the amendments to the agreement signed in the March 20, 2006 between the government and the National Bank" in 2016 on March 15, was carried out the upgrade of 400,846.0 thousand GEL issued by the government in 2015 on March 15 worth 360,846.0 thousand Gel, with paying annual interest 11,514 percent and for the assignment of 40,000.0 thousand Gel into government bonds in the open market operations, including:
 - ✓ 10,000.0 thousand Gel was registered by payment 14.000 percent annual interest;
 - ✓ 8,000.0 thousand Gel by payment 14,125 percent annual interest;
 - ✓ 12,000.0 thousand Gel by payment 14,250 percent annual interest;
 - ✓ 10,000.0 thousand Gel by payment 14,375 percent annual interest.

Also, according to the above-mentioned agreement, in 2016 on March 15, was carried out "bonds in the open market' released on 15 March 2011 covering 6,000.0 thousand GEL, in 2016 June 15, was carried out "bonds in the open market' released on 15 March 2012 covering 12,000.0 thousand GEL and in 2016 September was carried "the bonds in the open market" released on March 15, 2013 covering the amount of 10,000.0 thousand Gel.

• During the reporting period, in respect of the total funding of the various elections was allocated 14 986.8 thousand Gel, including 479,4 thousand GEL for the special election of the district governor of Gardabani in 2016, 880.2 thousand GEL for the elections in Gardabani, Kaspi, Tskaltubo, City Ozurgeti, Ozurgeti, Khobi and Zugdidi municipalities, 13 627.2 thousand GEL at the parliamentary elections (1 October) of Georgia;

• According to the current legislation of Georgiaunder the distribution of the funds allocated to political parties was don, 11 political parties were funded;

• During the reporting period, the state awards monetary prizes were issued to 64 persons. 38.6 thousand Gel was allocated for this purpose.

State Budget Expenditures by Economic Classification

By the article of **"labor compensation"** in the reporting period, the adjusted plan has been set with 1 090 190.9 thousand GEL, and execution of the cash amounted to 1 074 722.0 thousand GEL, which is 98.6% of the planned figure. Cash execution of "labor compensation" is 17.2% of the "costs" of cash performance and 14.6% of the state budget taxes.

By the article of "**goods and services**" in the reporting period, the adjusted plan has been defined with 832 458.4 thousand GEL. Cash execution amounted to 777 667.6 thousand GEL, which is 93.4% of the plan. Cash execution of "Goods and Services" is 12.4% cash performance of "costs" and 10.6% of the state budget taxes.

From the category "Goods and Services" according to the economic classification articles the rest of the cost structure is as follows:

- Contracted workers' compensation 123 384.4 thousand GEL;
- Business trips 56 160.4 thousand GEL;
- Office expenses 125 429.3 thousand GEL;
- Representative Expenses 14 502.4 thousand GEL;
- Food costs 53 393.4 thousand GEL;
- Medical costs 30 224.2 thousand GEL;
- Soft inventory, uniform and personal hygiene-related costs 16 821.4 thousand GEL;
- Vehicles, equipment and weapons operation and maintenance costs 86 905.3 thousand GEL;
- Military equipment and ammunition acquisition costs 35 299.1 thousand GEL;
- Other goods and services 235 547.8 thousand GEL.

By the article of **"Interest"** in the reporting period, the cash execution amounted to 296 911.1 thousand Gel (98.0% of the adjusted plan 302 875.2 GEL), which is 4.0% of the state budget expenditures. Percent of the foreign debt service was directed to 125 280.5 thousand GEL, while the domestic debt service was directed to 171 570.8 thousand GEL.

By the article of **"Subsidies"** in the reporting period, the adjusted plan 244 721.9 thousand Gel And cash execution amounted to 236 900.4 thousand GEL, which is 96.8% of the plan, while the state budget expenditures 3.2% of the total.

From the article of "Subsidies" mainly were financed such important programs, such as:

- ✓ Sports development supporting events 59 340.0 thousand GEL was allocated in respect of the events organized by the Minister of Sport and Youth Affairs during the reporting period, which is 97.5% of the planned figure;
- ✓ 37 042.8 thousand GEL was allocated to discounted agro-credit program, which is 100.0% of the planned figure;

- ✓ the road infrastructure improvement events 25 495.8 thousand GEL was allocated in respect of the events organized by the Ministry of Regional Development and Infrastructure, which is 88.8% of the planned figure.
- ✓ entrepreneurship development 19 052.7 thousand GEL was allocated in total, which is 92.6% of the planned figure;
- ✓ promotion of science and research 13 630.3 thousand GEL in total was allocated for it, which is 91.2% of the planned figure;
- ✓ modernization of irrigation systems 9 000.0 thousand GEL in total for allocated for this, which is 100.0% of the planned figure;

By the article of **"Grants"** in the reporting period, the cash execution amounted to 677 144.4 thousand GEL, which is 95.8% (707 003.2 thousand GEL) of the adjusted for planned indicator and 9.2% of the state budget expenditures.

By the article of **"social welfare"** in the reporting period, the cash execution amounted to 2 303 899.3 thousand GEL, which is 98.8% (2 332 162.6 thousand GEL) of adjusted planned parameters and 31.4% of the state budget expenditures.

From the article of social welfare were financed important measures, such as:


- ✓ Providing pension for the population 1 153 105.7 thousand GEL was allocated in the respect of it, which is 100.0% of the planned figure;
- ✓ Ensuring Universal Public Healthcare 492 263.9 thousand GEL was allocated in respect of it, which is 97.2% of the planned figure;
- ✓ Social assistance of the targeted groups of population 482 877.4 thousand GEL was allocated in respect of it, which is 99.3% of the planned figure;
- ✓ Ensuring public healthcare and the provision of health care delivery programs in the priority areas 123
 144.2 thousand GEL was allocated in total in respect of it, which is 94.5% of the planned figure;
- ✓ Social rehabilitation and child care 12 437.3 thousand GEL was allocated in respect of it, which is 85.2% of the planned figure;

By the article of **"other expenses"** in the reporting period specified plan was allocated to 969 596.1 thousand GEL, while the cash cost incurred at 888 699.7 thousand GEL which is 91.7% of the plan. The cash performance of "other expenses" is 14.2% of the cash performance of "expenses" while it is 12.1% of the state budget expenditures


From the article of "other expenses" were financed important measures, such as:

- ✓ Secondary school funding 377 041.6 thousand GEL was allocated in respect of it, which is 99.2% of the planned figure;
- ✓ Regional and Municipal Infrastructure Rehabilitation 111 587.7 thousand GEL was allocated in respect of it, which is 67.3% of the planned figure;
- ✓ The state studying, master grants to encourage young people 57 003.7 thousand GEL was allocated in respect of it, which is 98.8% of the planned figure;
- ✓ spring support measures of farmers 49 284.4 thousand GEL was allocated in respect of it, which is 100% of planned figure;

- ✓ support to internally displaced persons (including home construction / rehabilitation of IDPs) 41
 353.8 thousand GEL was allocated in respect of it, which is 212.3% of the planned figure;
- ✓ Millennium challenge to Georgia (MCG) 34 144.9 thousand GEL was allocated in respect of it, which is 60.3% of the planned figure;
- ✓ educational institutions and providing pupils / students with information and communication technologies - 24 062.6 thousand GEL was allocated in respect of it, which is 97.5% of the planned figure;
- ✓ restoration and rehabilitation of water supply infrastructure 20 425.2 thousand GEL was allocated in respect of it, which is 70.9% of the planned figure;



According to the main functional categories the structure of the performance of the 9 months of 2016 state budget is characterized by:

1 332 395.6 thousand GEL was planned to finance general government services sector. Cash execution amounted to 1 265 421.4 thousand Gel, 95.0% of the planned figure, while total costs and 18.9% of non-cash increase performance, including the followings:

funding the activities of executive and representative bodies, financial and fiscal activities, external relations, amounted to 253 129.3 thousand GEL, which is 84.9%(298 178.2 thousand GEL) of the plan;

general-purpose service funding amounted to 27 743.9 thousand GEL, which is 99% (27 714.1 thousand GEL) of the plan;

cash expenditures related to debt operations amounted to 296 851.3 thousand GEL, which is 98% (302 815.4 thousand GEL) of the the plan;

general cash flow between different levels of government funding amounted to 647 091 thousand, which is 98.3%(658 186.2 thousand GEL) of the plan;

For funding other non-classified activities appropriations in general state services amounted to 40 906 thousand GEL, which is 89.9% (45 501.7 thousand GEL) of the plan.

- For fudning defense activities was planned 497 374.7 thousand GEL. Cash execution amounted to 504 955.7 thousand GEL, 101.5% of the planned figure, while 7.5% of total costs and non-cash increase cash performance inclduign the following:
 - ✓ armed forces funding amounted to 442 696.8 thousand GEL, 103.6% (427 thousand GEL 459.7) of the plan;
 - ✓ foreign military assistance funding amounted to 30 852.1 thousand GEL, 80.1% of (38 518.3 thousand GEL) the plan;
 - ✓ funding of the applied research in defense amounted to 30 291.3 thousand GEL, which is 100.8% (30 045.4 thousand GEL) of the plan;
 - ✓ Funding the other non-classified activities in the field of defense allocations amounted to 1 115.5 thousand GEL, which is 82.6%(1 351.3 thousand) of plan.

• in the field of public order and safety 764 283.0 thousand GEL was allocated. Cash execution amounted to 724 822.8 thousand, 94.8% of the planned figure, while total costs and non-financial asset increases cash performance - 10.8%. including the following:

- ✓ Police Service and the State funding amounted to 414 674.5 thousand GEL, the 98.4% (421 338.9 thousand GEL) of the plan;
- ✓ Fire department service funding amounted to 44 469.2 thousand GEL, 95.1% (46 778.1 thousand GEL) of the plan;
- ✓ the courts and the prosecutor's funding amounted to 78 014.2 thousand GEL, which is 93.5% (83 449.5 thousand GEL) of the the plan;
- ✓ provided funding for penal institutions amounted to 86 486.7 thousand GEL, which is 85.2% (101 511.5 thousand GEL) of the the plan;
- ✓ in the field of the public order and safety funding of the other non-classified activities appropriations amounted to 101 178.2 thousand GEL, which is 91% (111 205 GEL) of the plan;

• For funding economic activities 845 203.3 thousand GEL was planned, while the cash execution amounted to 725 308.4 thousand GEL, the 85.8% of the planned figure, 10.8% of the total costs and non-financial asset increase cash performance, including the following:

- ✓ funding of the overall economic, commercial and labor-related activities amounted to 39 878.6 thousand GEL
- ✓ Funding of agriculture, forestry, fisheries and hunting amounted to 162 866.1 thousand GEL, which is 91.3% (178 381.4 thousand GEL) of the plan;
- ✓ Funding spent on fuel and energy amounted to 15 903.8 thousand GEL, which is 100.1% of the the plan (15 889.0 thousand GEL);
- ✓ For funding mining and mineral processing industry and construction was directed 864.7 thousand GEL, 97.9% (882.9 thousand) of the plan;
- ✓ transport funding amounted to 404 392.7 thousand GEL, the 83.6% of (483 692.0 thousand GEL) the plan;
- ✓ funding of other economic sectors amounted to 80 877.6 thousand GEL, 83.2% of (97 232.5 thousand GEL) the plan;
- ✓ funding of economic activities in the area and other unclassified appropriations amounted to 20 525.0 thousand GEL, which is 92.2% (22 256.1 thousand GEL) of the plan;

• For funding environmental protection fiel was planned 38 968.1 thousand GEL, while the cash execution amounted to 36 939.1 thousand GEL, 94.8% of the planned figure, while 0.6% of the total costs and non-cash increase of the cash performance, including the following:

- ✓ funding of waste collection, recycling and destruction amounted to 4 165.3 thousand GEL which is 119%(3 500.0 thousand GEL) of plan;
- ✓ Funding in fighting against environmental pollution amounted to 611.5 thousand, which is 92.7% (659.9 thousand), of the plan;
- ✓ funding of biodiversity and landscape protection amounted to 15 071.6 thousand GEL, which is 95.5% (15 789.0 thousand GEL) of the plan;



The Reserve Fund of the Government of Georgia

- ✓ By the Georgia law about "The 2016 state budget of Georgia" the increase of the resources of the funds, according to the government's resolution N1405 was defined with 5 000.0 thousand Gel (foreign state debt service and defined amount for payment on the basis of reducing allotments);
- ✓ According to the resolution of the government of Georgia on August 13 N1585 regarding the "carrying out the measures" - 76 300.0 thousand Gel (including 60 000.0 thousand GEL - foreign state debt service and defined amount for payment on the basis of reducing allotments, while 16 300.0 thousand GEL – according to the mentioned resolution for the spending agencies at the expense of the annual budgetary allocations law).

 \checkmark In addition, for funding the efforts aimed Georgian Football development, by the 3rd paragraph of N30 protocol XXXVI of the government of Georgia released on September 16, 2016 the Ministry of Finance was entrusted with finding resources for increasing the government's reserve fund.

During the reporting period, by the government resolutions and orders of the Prime Minister of Georgia allocations released from the government's reserve fund amounted to 157 211.5 thousand GEL, and cash performance - 87 269.2 thousand GEL.

At the same time, on the bases of decrease the foreign debt service and payment allocations the fund for the projects which are to be implemented in the regions of Georgia was increased by 35 000.0 thousand Gel ("about the 2016 state budget of Georgia" about the increase of the fund resources for the conserned funds by the law of Georgia" according to the resolution of Georgian government issued on July 14, N1405, and the resolution N1585 "about some of the measures which are to be implemented" issued on August 13). Therefore, the Fund appropriations at the end of the reporting period was determined by 315 000.0 thousand GEL.

During the reporting period the resolutions approved by the government of Georgia allocated funds by the normative acts from the Regional Development Fund amounted to 314 051.1 thousand Gel, and the funds transferred by the Treasury - 202 509.1 thousand Gel.





> The structure of the state securities balance For the end of the reporting period





By the resolution # 546 of the government of Georgia dated on March 31, 2016 from the reserve fund to the Telavi municipality was allocated 300.0 thousand Gel, from which according to the condition for October 1 was transferred 183.9 thousand GEL.

By the resolution # 826 of the government of Georgia dated on May 16, 2016, from the reserve fund of the municipality of the city government was allocated to 150.0 thousand Gel, from which according to the condition for October 1 was transferred 110.4 thousand Gel.

By the resolution # 975 of the government of Georgia dated on May 30, 2016 from the reserve fund of the city of Poti municipality was allocated 500.0 thousand GEL, which is completely transferred.

Given the fact that at the expense of increase their income Poti municipality equalization transfer in 2016 is not provided, by Poti municipality in 2016 budget to ensure smooth financing measures by the resolution N294 of the government of Georgia dated on February 25, 2016 from the reserve fund as a loan was allocated 2 000.0 Gel, from which was transferred 1 970.0 thousand Gel. The amount of the loan according to the condition for October 1 was completely paid back to the budget.

For the purpose of financing activities provided by Mestia Municipality 2016 budget, by the resolution N1930 of the government of Georgia dated on September 16, 2016 in the form of a loan from the government's reserve fund was allocated 400.0 thousand GEL to the local municipality, according to the condition for October 1 was transferred 400.0 thousand Gel. The mentioned loan will be repaid by the end of 2020.

Rural Support Program funding allocated amounted to 50 000.0 thousand GEL, according to the condition for October 1 was transferred 22 913.6 thousand Gel.
